ORDER:

In the reference first read above, the Managing Director, Andhra Pradesh Scheduled Castes Cooperative Finance Corporation Limited has reported among other things that they are implementing the scheme of purchase of agricultural lands for poor scheduled Caste Landless Agricultural Labourers. The beneficiaries are entitled for financial assistance through District Scheduled Caste Cooperative Society after they become member of the Society as the scheme is exclusively implemented for Scheduled Caste landless agricultural labourers. He has requested the Government to accord sanction for exemption from payment of stamp duty and registration fee in respect of the lands purchased for allotment to the Scheduled Caste families under the scheme of purchase of agricultural lands being implemented by the Andhra Pradesh Scheduled Castes Cooperative Finance Corporation Limited, Hyderabad.

2. After careful examination of the proposal, the Government hereby accord sanction of exemption from payment of stamp duty and Registration fee in respect of the lands purchased for allotment to the Scheduled Caste families under the scheme of purchase of agricultural land being implemented by the Andhra Pradesh Scheduled Caste Cooperative Finance Corporation Limited, Hyderabad.
3. The appended notifications shall be published in the next issue of Andhra Pradesh Gazette.
