ORDER:

In the reference 1st read above, the Dist. Collector, Visakhapatnam requested the Metropolitan Commissioner, VMRDA, Visakhapatnam to get necessary orders to delete the lands i.e., reconstituted plots area from the list of prohibited properties notified under Section 22-A so as to facilitate the individuals with alienable rights on their reconstituted plots under the Transfer of Property Act, 1882 as was mentioned in the LPOC Certificate.

2. In the reference 2nd read above, the Metropolitan Commissioner, VMRDA, Visakhapatnam has informed that Government vide memo No.MAU01/1702/2022-M Revenue (Lands-I) Department dated 06.03.2023 accorded permission for deletion of lands from the list of Prohibited lands u/s.22A(1)(a) and 22A(1)(b) of Registration Act, 1908 pertaining to assigned/encroached Government lands pooled by VMRDA for the purpose of NPI layouts and MIG layouts.

3. In the reference 3rd read above, the Metropolitan Commissioner, VMRDA, Visakhapatnam informed that as per Rule 12(5) of the Visakhapatnam Urban Development Authority (VUDA) Land Pooling Scheme (formulation and implementation) Rules 2016 issued in G.O.Ms.No.290 MA&UD(H1) Dept., dated 14.11.2016, the LPOCs granted shall be registered without charging registration fee from the land owners in accordance with the provisions of the Registration Act, 1908 as mentioned u/s.25 and Section 31(4) of the A.P.Metropolitan Region and Development Authorities Act, 2016 (Act 5 of 2016).The Metropolitan Commissioner, VMRDA, Visakhapatnam has requested to issue instructions to the District Registrar, Registration & Stamps Department, Visakhapatnam to register the LPOCs at free of cost in all aspects in terms of Rule 12(5) of the VUDA LPS Rules 2016 or to issue orders for exemption of Stamp Duty, Registration fee and user charges.

4. In the reference 4th read above, the Commissioner and Inspector General, R&S, A.P., Vijayawada has submitted the following financial implications:

5. The C&IG, R&S informed that Government is the competent authority to exempt Stamp duty under Section 9 of Indian Stamp Act, 1899 and Registration Fee U/s.78 of Registration Act, 1908.

6. Government after careful examination of the matter have decided to exempt the registration fee and Stamp Duty on all deeds pertaining to register the LPOCs at Visakhapatnam.

7. Accordingly, the following notifications will be published in an Extraordinary Issue of the Andhra Pradesh Gazette:

NOTIFICATION-I

In exercise of the powers conferred by clause (a) of Sub-section (1) of Section 9 of the Indian Stamp Act, 1899 (Act.II of 1899), the Governor of Andhra Pradesh hereby remits the Stamp Duty in full chargeable on all deeds pertaining to register the LPOCs at Visakhapatnam.

NOTIFICATION-II

In exercise of the powers conferred by Section 78 of the Registration Act, 1908 (Act XVI of 1908), the Governor of Andhra Pradesh hereby makes the following amendment to the Book 1 of CARD of "Table of Fee" issued in G.O.Ms.No.4546 Revenue (Regn.I) Dept., dated 01.12.2012 and subsequently amended from time to time.

AMENDMENT

In the said "Table of Fees" after category 6(o), the following shall be added as 6(p) namely:

6(p) No registration fee shall be levied on all deeds pertaining to register the LPOCs at Visakhapatnam.
